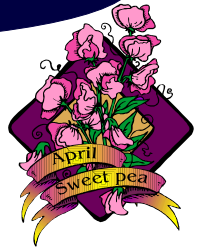

GPO-WEP WASHINGTON SUMMIT REPORT

You would have been very proud to be a member of TRTA/MARSP if you could have been with me and the other TRTA officers and Tim Lee, our Executive Director, in Washington, DC on March 10 and 11. Our reason for being there was to attend a GPO/WEP Summit hosted by TRTA. Eighteen different associations representing eight states participated, including representatives from TCTA and ATPE! This summit was the first-ever coordinated effort to work on some kind of legislative relief from the penalties these two laws impose on retirees in fourteen states.

Presenters at the two-day summit, held in a meeting room at the U.S. Capitol, included national and state associations advocating for GPO/WEP reform, as well as three members of Congress (Sen. Kay Bailey Hutchison of Texas, Rep. Kevin Brady of Texas, and Rep. Aaron Schock of Illinois) and a staffer for Rep. Howard Berman of California. Hutchison and Brady have filed bills (H.R. 1221/S. 491) to revise the calculation of the WEP, and Berman has filed legislation to completely repeal both the GPO and WEP (H.R. 235). Staff members from the Social Security Administration and the Government Accountability Office were also on hand to provide background information and statistics on the entitlement program and the impact of the two offsets.

(continued from Page 1) presentations, TRTA officers met with their own representatives and I had a fruitful meeting with Rep. Mike Conaway in his office. He is one of the co-sponsors of H. R. 1221. However, he, like the rest of the congressmen with whom we visited, does not feel that anything will happen on this until the health care issues are resolved. We learned that the bill cannot come out of committee until called for by the Speaker of the House. Every Congressional member we talked with agreed that the GPO/WEP are the two issues that they receive the most constituent calls/letters/emails about when discussing Social Security.

In the final afternoon of the Summit, participants talked about the next steps the organizations should take. They decided that there was a need for solid data on just how many individuals are penalized and to what extent. They expressed an interest in surveying their organizations' members to find out how many people are affected by the GPO, WEP or both. TRTA will draft the survey, publish it in the next issue of The Voice and provide it to all other summit participants for their use as well. This survey will help identify the hundreds of thousands of public education and other public employee retirees around the country that are affected by the GPO/WEP.

The bottom line on the GPO/WEP Summit is that the meeting helped give the participants clarity about how Congressional members perceive this issue. While no solution will come easily and it may not result in everything we may hope to achieve, dealing with the GPO/WEP in a way that helps restore your Social Security benefits is possible. TRTA will do all it can to help advance these efforts as quickly as possible and this Summit helped build a coalition of other associations which are now going to join in that effort.

Health Corner—Rx For a Broken Toe

Even minor fractures can shed bone fragments that cause persistent irritation. A greater risk is that the toe will heal in a "misaligned" position, causing arthritis or balance problems later. Toe fractures should always be seen by a podiatrist or orthopedic specialist. Fast treatment helps ensure that the bone heals quickly and in the normal position. If the toe is black and blue, it's almost certainly broken. (Johanna Youner, DPM)
