- Answer: AMBA is the exclusive provider of TRTA's dental and vision programs today.

### **Question 2:** What about Trident?

- Answer: TRTA is winding down its partnership with Trident on the dental/vision programs. If someone has dental/vision through Trident, we are working with AMBA on options for those members. Representatives of TRTA and AMBA will be contacting these TRTA members.

### **Question 3:** What about other products (MASA, Life Insurance, etc.) purchased through AMBA in the past?


- Answer: Those AMBA policies will continue so long as you pay your premium.

### **Question 4:** May I invite an AMBA representative to TRTA District or local unit meetings to provide information on benefits? Will AMBA still provide payment to local units for yearbook ads?

- Answer: At this time, AMBA is TRTA's endorsed agent and third-party administrator only for the TRTA group dental plan with Ameritas and the TRTA vision plan with VSP. You may invite AMBA representatives to speak about the dental/vision programs; however, this decision is made at the local level. In addition, you may reach out to AMBA to advertise in your yearbook and receive payment for your local unit for these ads.

### **Question 5:** Last summer TRTA and AMBA were in a lawsuit, but today AMBA is the exclusive endorsed dental/vision provider. Can you provide background on what has happened?

Answer: In 2021, TRTA and AMBA had been engaged in a legal process regarding which contracts governed our relationship. Over the last few months, members of the TRTA Board and Tim Lee, TRTA's Executive Director, have met with AMBA's Chief Executive Officer and their leadership team on a weekly basis. These conversations have been a wonderful opportunity for TRTA leadership to gain a deeper understanding of the terrific work AMBA does on behalf of TRTA and our members. 
## MARSP Volunteer Hours
