### **TRTA Fall District Conference**

The Fall TRTA District Conference was held at Region 18 on October 3rd. TRS reported that investment returns are up from last year. Through legislation the contribution to TRS is increasing. Senate Bill 1854 will make TRS-Car members eligible to open enrollment for Vision & Dental Coverage. Enrollment will be in Fall of 2024 and start in January 2025. Pharmacy will change back to Express Scripts in January 2024, You will receive a new drug card in December 2023. You should not have to change pharmacies. New Officers for District 18 will be:

- 1. No public school retiree since 9/1/2004 has ever received a costof-living adjustment. Most retired teachers are not eligible to receive Social Security; therefore, a TRS pension is their primary source of income.
